Attached are copies of the documents contained in our administrative file relating to Mr. Salazar, with the exception of his Certificate of Naturalization. Reproduction of the certificate is prohibited by statute, 18 U.S.C. 1426(h); therefore it is also exempt from disclosure under the provisions of 5 U.S.C. 552(b)(3). However, for your information, Mr. Salazar was naturalized on November 27, 1953, at a term of the United States District Court at El Paso, Texas.

Your request for a waiver of fee has been denied. Writing a book, for which you will receive monetary compensation, does not mean that the release of the requested material would be in the public interest. Therefore, at the rate of ten cents (\$.10) per page as prescribed by Department of Justice regulations (23 CFR 16.9), the cost for duplication of the record is \$4.90. You will receive a bill for that amount.

Dear Sir or Madam:

This appeal concerns the determination by the Immigration and Naturalization Service to charge me for the duplication of records kept by that agency for Ruben Salazar, the Los Angeles journalist killed on August 29, 1970. The denial of my request for the waiver of fees was communicated to me in the cover letter accompanying Mr. Salazar's near-complete file, dated June 4, 1982.

Again I insist that the release of any government files concerning the life and death of this controversial newsman is in the public interest. In particular, I mentioned in my original request to the INS, as I have done in similar requests to the FBI, CIA, Justice Department, and State Department, that this information is for use in published news articles and a biography of Mr. Salazar I hope to write. The INS letter informing me that the fee waiver had been denied argued that the money I will receive from a possible book implies that, somehow, the release of information isn't in the public interest, or that anyone who makes their living as a journalist therefore has a personal, rather than public, interest in the disclosure.

I hope that you will agree that this line of reasoning is faulty, and will overrule the decision to charge me \$4.90 for Mr. Salazar's file. I'm enclosing a copy of the bill sent to me by the INS, which I will not pay, pending your decision. As corroborating argument, let me say that neither the FBI's central files, Los Angeles Field Office files, CIA files, or State Department files were given to me with fees. They were all matters of the same public interest, and all given to me as FOIA disclosures, yet none were charged to me.

I have lost more money than I will conceivably ever make by pursuing the story of Mr. Salazar's life and death. This, also, should be a factor in your decision.

Dear Mr. Baran:

An appeal has been lodged with the Justice Department's Office of Legal Policy to review your office's decision to bill me for the copying of Ruben Salazar's INS file, disclosed to me earlier this year under the Freedom of Information Act. I am enclosing copies of both my appeal letter, and acknowledgement of receipt by Janice Adams.

As I informed the Office of Information and Privacy Appeals in my letter, I have no intention of paying either the \$4.90 or any late penalties until this matter has been resolved. I am totally confident that your decision to charge me on the basis of an alleged personal, rather than public, interest in a free-lance reporter using the Act will be overturned. As I also say in the letter, none of the previous agencies that have disclosed some or all of their dossiers on Mr. Salazar have charged me. I'm sure that you understand that if your office sets a precedent, I can be liable for many other charges for much more extensive search and copying costs. All of this, of course, runs counter to the letter and spirit of the Freedom of Information Act.

I'm sorry that I didn't send you a copy of my appeal letter when I originally filed it in June. If possible, please reconsider your office's decision, and a quick, efficient decision can resolve the appeal. If that isn't possible, then you'll just have to wait until the entire appeal process is resolved for any payment from me. By the way, I am presently considering donating Mr. Salazar's INS file to the Los Angeles Library's Chicano Resource Center, the country's only such public-access facility outside of Texas. That, I'm sure, will finish off any argument your office might have had for considering the FOIA disclosure as personally beneficial to me.

You appealed from the refusal by the Immigration and Naturalization Service to grant your request for a waiver of the customary reproduction charges involved in the processing of your request for records pertaining to Ruben Salazar.

On the basis of the information available to me, it is my judgment that a waiver of fees in this case should not be granted. The single test I have applied is whether the actual release to you of the information in question can be said to be of primary benefit to the general public. The records in the INS file consist of routine correspondence and applications and it is my opinion that these materials are not of sufficient substantive value to benefit the public. Accordingly, your request for a fee waiver is denied.

Judicial review of my action on this appeal is available to you in the United States District Court for the judicial district in which you reside or have your principal place of business, or in the District of Columbia, which is also where the records you seek are located.
