



As pointed out in enclosed Press Release, Sheriff PETER J. PITCHESS (a personal friend of MEYER), Los Angeles County Sheriff's Office (LACSO), has been furnishing MEYER with complete reports of the LACSO investigation. Also Assistant U. S. Attorneys attended the coroner's inquest (regarding SALAZAR's death) on a daily basis.

In accordance with instructions set forth in the Manual of Instructions, Section 27D (2), no action is being taken by the Los Angeles Office, UACB. It is recommended no investigation be conducted in view of the above, particularly since no useful purpose would be served other than offsetting any possible criticism of the USA.

In accordance with existing Departmental policy regarding major confrontations between local law enforcement officers and groups of persons and in matters involving ment officers and groups of persons and in matters involving deaths, no investigation will be conducted in absence of a specific request from the Civil Rights Division.

Reference is also made to prior communications from this Bureau captioned "National Chicano Moratorium, August 29, 1970, Spanish Americans, Civil Rights", the last memorandum being furnished your office on 10/8/70.
