They also prohibit Americans from making unlicensed purchases in Cuba of any goods whether for consumption, exportation, or importation into the United States. Application forms for the necessary license and any additional information you may require are obtained from the Foreign Assets Control, Treasury Department, Washington, D. C. 20220 or the Foreign Assets Control Division, Federal Reserve Bank of New York, 33 Liberty Street, New York, New York, 10045.
